## The Master of Science in Global Urban Health

#### INTRODUCTION

Global health is the health of populations in a global context and transcends the perspectives and concerns of individual nations; it is about worldwide improvement of health, reduction of disparities, and protection against global threats that disregard national borders. Urban health is about the health challenges of the growing urban populations (1.02 billion additional people in 14 years with



an upwards trend) including health risks by air and water pollution, noise, stress, the impact of violence, dissolving

families, migration, unhealthy food, reduced physical activities, overburdened health services with the double threat of communicable and non-communicable-diseases and others.

## GENERAL CHARACTERISTICS OF THE MSc

This Modular course will be taught in English and will be offered for postgraduate students worldwide covering one academic year.



The MSc GUH course, which is hosted by the philosophical faculty and organized by the ZMG (Centre for Medicine and

Society), will be taken as a full time course with subsequent field study (for the MSc thesis) to be completed abroad or as desk study in Freiburg. The master course

includes interdisciplinary approaches with input from several faculties of Freiburg University and external lecturers. It will offer excursions to WHO-Geneva, relevant institutions in Basel and Strasbourg and will show the efforts of the city of Freiburg to create healthy living conditions.

#### **TOPIC AREAS**

The MSc in Global Urban Health is organized through an interdisciplinary effort using participatory learning techniques; it covers different topic areas in relation to urban health needs:

#### Analysis tools

- Epidemiology & statistics
- Social sciences including economics
- Geography & anthropology

#### Health assessment & interventions

- Primary mental care dealing with stress, depression and other issues
- Communicable diseases & transmission dynamics
- Non-communicable diseases (NCDs) & prevention
- Social mobilization strategies
- Management of urban health systems
- Quality management
- Alternative medical systems

## Environmental threats & treatment

- Air, water, soil pollution, noise
- Urban micro-climates
- Urban planning and land use

#### Social challenges

- Migration; violence; gender issues
- Social mobilization

#### **PREREQUISITES**

The MSc is open to professionals in health, social sciences including economics, urban planning and others, holding a higher academic degree (Minimum 4 years of academic full time training) and at least two years of working experience. Proficiency in the English language is required.
